Eligibility

It's up to you to understand who you can cover under your medical, dental, vision, and other benefits. Be sure to review the information below *before* you enroll in coverage.

You are eligible to participate in OnePlus if you are a:

- Regular full-time team member scheduled to work at least 30 hours a week, or
- Regular part-time team member scheduled to work at least 20 hours, but less than 30 hours, each week.*

Part-time team members are eligible for the same OnePlus benefits that are available to full-time team members.

Eligible Dependents

Dependents who are eligible for OnePlus medical, dental, vision, and spouse and/or dependent life insurance benefits coverage include your:

- Spouse or domestic partner**;
- Biological children, stepchildren, legally adopted children, children to whom you are a legal guardian up to age 26***†;
- Handicapped children of any age who are unmarried, disabled, and rely on you for support; and
- Domestic partner's eligible children up to age 26***†.

Please note, when you are enrolling your dependents, Ricoh expects you to provide accurate information. It is important to ensure that only eligible dependents are enrolled in Ricoh coverage. Dependents who are not eligible for coverage or for whom you are unable to provide documentation will be dropped from coverage.

Ricoh has implemented Plan Guard to verify the eligibility of dependents covered under the OnePlus plans. Dependents who are not eligible for coverage or for whom you are unable to provide documentation will be dropped from coverage.

*Other state mandates may apply.

**There is an additional amount you may pay for medical coverage each pay period if you enroll a spouse or domestic partner who has access to medical coverage from his or her employer.

***Not eligible for spouse or dependent life insurance if also employed by Ricoh.

† Coverage ends the last day of the month after dependent's 26th birthday.

Medical Coverage Level

Which Coverage Level Is Best?

When you choose your coverage level, you get to pick the one with the coverage and features you want. If you're enrolling again, consider what changes you may be facing. Change is constant, so make sure you [do your homework](#) before sticking with what you had in the past.

Your coverage level determines how much you pay out of your paycheck (premiums). It also determines how much you pay out of your pocket when you receive care (deductibles, coinsurance, copays).

Don't let the names of the coverage levels fool you. One option isn't better than another. The coverage levels are designed to give you choices. It's up to you to find the one that makes sense for your situation.

Medical Coverage Level Options

You have several coverage levels to choose from. Each coverage level is available from different [insurance carriers](#) at different costs.

When you enroll, you'll find plenty of tools and resources to help you choose a coverage level.

A Word About Taxes

The IRS requires that you pay taxes on the value of certain benefits coverages extended to you by Ricoh. The value of these coverages is considered imputed income. This coverage includes medical benefits coverage for domestic partners and their eligible dependents.

Imputed income means that you pay federal income and Social Security taxes on the value of certain OnePlus benefits. Imputed income is paid so that the benefit is not considered taxable to you at the time you need it the most. Ricoh will report imputed income on your Form W-2 at year-end.

Do You Take Any Prescription Drugs?

Your prescription drug coverage will be provided through your insurance carrier's pharmacy benefit manager.

Live In California?

Your options will be different, depending on the insurance carrier you choose.

For starters, each **insurance carrier** in California can elect to offer each coverage level either as an option that offers in- and out-of-network benefits (e.g., a PPO) **or** an option that offers in-network benefits only (e.g., an HMO).

Also, insurance carriers can choose to offer **either the standard Gold option or a Gold II option—not both**. The Gold II option offers **only** in-network benefits.

Review the table below to see which insurance carriers offer out-of-network benefits for the coverage levels you're considering.

How Deductibles Work

The deductible is what you pay out of your own pocket before your insurance begins to pay a share of your costs.

For example, let's say you break your wrist. If you have a deductible, you pay the full "negotiated" costs of all in-network services until you reach the deductible. The "negotiated" costs are the payments providers (doctors, hospitals, labs, etc.) have agreed to accept for a particular service from the [insurance carrier](#). Insurance carrier member sites and apps have resources that can help you look up the cost of care.

It Depends On Your Medical Coverage Level

Bronze, Gold, and Platinum have a traditional deductible. Once a covered family member meets the individual deductible, your insurance will begin paying benefits for only that family member.

Charges for all other covered family members will continue to count toward the family deductible. Once the family deductible is met, your insurance will pay benefits for all covered family members.

The annual deductible doesn't include amounts taken out of your paycheck for health coverage.

Bronze Plus and Silver have a "true family deductible". This means that the entire family deductible must be met before your insurance will pay benefits for any covered family members.

There is no "individual deductible" in the Bronze Plus and Silver coverage levels when you have family coverage. So even if only one person in your family has a lot of expenses, the full family deductible must be met before insurance will begin to pay its portion of benefits.

The annual deductible doesn't include amounts taken out of your paycheck for health coverage. Also, copays for certain medical benefits may not apply towards the annual deductible.

Do You Use Out-of-Network Providers?

Out-of-network charges will **not** count toward your in-network deductible or out-of-pocket maximum. The same goes for in-network charges—they will **not** count toward your out-of-network deductible or out-of-pocket maximum.

Some insurance carriers in CA, CO, DC, GA, MD, OR, VA, and WA, do **not** cover out-of-network benefits at all.

How Out-of-Pocket Maximums Work

The out-of-pocket maximum is the most you have to pay for covered medical services in a year. Generally, it includes any applicable deductible, copayments, and/or coinsurance.

It Depends On Your Medical Coverage Level

Bronze, Gold, and Platinum have a traditional out-of-pocket-maximum. Once a covered family member meets the individual out-of-pocket maximum, your insurance will pay the full cost of covered charges for that family member.

Charges for all covered family members will continue to count toward the family out-of-pocket maximum. Once the family out-of-pocket maximum is met, your insurance will pay the full cost of covered charges for all covered family members.

It doesn't include amounts taken out of your paycheck for health coverage.

Bronze Plus and Silver have a "true family out-of-pocket-maximum". This means that the entire family out-of-pocket maximum must be met before your insurance will pay the full cost of covered charges for any covered family member.

There is no "individual out-of-pocket maximum" in the Bronze Plus and Silver coverage levels when you have family coverage.

The annual out-of-pocket maximum doesn't include amounts taken out of your paycheck for health coverage.

Do You Use Out-of-Network Providers?

Out-of-network charges will **not** count toward your in-network deductible or out-of-pocket maximum. The same goes for in-network charges—they will **not** count toward your out-of-network deductible or out-of-pocket maximum.

Some insurance carriers in CA, CO, DC, GA, MD, OR, VA, and WA, do not cover out-of-network benefits at all.

Medical Price

How much you pay out of your paycheck is one thing. You also have to consider what you'll pay throughout the year when you need care.

How much you'll pay for medical coverage depends on:

The Amount Of Your Subsidy Credit From Ricoh

All eligible team members will receive a subsidy credit to use toward the cost of coverage.

You'll see the subsidy credit amount from Ricoh and your price options for coverage when you [enroll](#).

The Coverage Level You Choose

The Bronze, Bronze Plus, and Silver coverage levels cost less per paycheck. With Bronze Plus and Silver, you will pay a higher deductible before your coverage kicks in. You will also have a higher deductible with Bronze; however, some services will be covered with a copay even if you haven't paid your deductible.

The Gold and Platinum coverage levels cost more per paycheck, but you'll probably pay less out of pocket for services throughout the year.

The Insurance Carrier You Choose

Since each coverage level is covered the same across carriers, it's easy to see which insurance carrier offers the lowest cost for the same coverage. For example, if you know you want a Silver option, you can look to see how much each insurance carrier would charge you for it. [Learn more about insurance carriers.](#)

Important: Choose an insurance carrier whose network includes providers critical to your care. If you see an out-of-network provider, your medical insurance carrier could pay a much lower benefit—leaving you to pay the rest.

Your Dependents

You can enroll any combination of you, your eligible spouse/domestic partner, and your children in the option you choose.

Pay Now or Later?

It's a trade-off. It's up to you to choose which option gives you the best value on your total health care costs.

Would you rather pay **less** now and **more** when you need care? Or pay **more** now and **less** when you need care?

Pay Less Now

The Bronze, Bronze Plus, and Silver coverage levels cost less per paycheck. With Bronze Plus and Silver, you will pay a higher deductible before your coverage kicks in. You will also have a higher deductible with Bronze; however, some services will be covered with a copay even if you haven't paid your deductible.

Make sure you know [how the deductible works](#). Also, make sure the deductible amount is something you could afford in the event you need a lot of health care.

TIP: You can save money by enrolling in an [HSA](#) when you enroll in a Bronze Plus or Silver coverage level.

Pay Less Later

The Gold and Platinum coverage levels cost more per paycheck, but your deductible is lower. If you don't expect to have a lot of health care needs, you could be spending money for benefits you don't use.

How to Get the Right Medical Option

Which Providers Are In The Carrier's Network?

Why It Matters

Seeing out-of-network providers will cost you more—sometimes a lot more. For example, you will have to pay more through a higher deductible and higher coinsurance. You'll also have to pay the entire amount of the out-of-network provider's charge that exceeds the maximum allowed amount. And certain options in some states won't cover out-of-network services at all.

What to Do

Choose an insurance carrier whose network includes providers (e.g., doctors, specialists, hospitals) critical to your care.

Do **not** rely on your provider's office to know the carriers' network(s). To search for providers:

- Check out the **insurance carrier** preview sites.
- When you enroll, check the networks of each insurance carrier you're considering on Your Benefits Resources at digital.alight.com/rus/. You can access this information by entering your provider information in the Help Me Choose tool or clicking **Find Doctors** when you're selecting your medical plan. For the best results:
 - Search for your provider by name—not medical practice.
 - Check only the office location(s) you are willing to visit.
 - When searching for a facility, use the complete facility name and confirm whether the specialty of the facility is covered in-network.

Important! Do **not** rely on your provider's office to know the carriers' network(s). If you have any uncertainty (for instance, covering out-of-area dependents) or you need the network name, call the insurance carrier.

Even if you can keep your current insurance carrier, the provider network could be different and can change, so always check the provider networks on the carrier preview sites before making a decision.

How Will My Prescription Drugs Be Covered?

Why It Matters

Each pharmacy benefit manager has its own rules about how prescription drugs are covered. To avoid potentially costly surprises, you need to do your homework.

What to Do

If you or a covered family member regularly takes medication, make sure you're comfortable with the insurance carrier's coverage for drugs you and your covered family members need:

- Call the medical [insurance carrier](#) before you enroll. Get a list of [prescription drug questions](#) to ask.
- If you're currently taking a more expensive brand name prescription drug, ask your doctor (or pharmacist) if a generic is available to you.
- When it's time to enroll, you can use the Help Me Choose tool to look up how your medication will be classified (Tier 1, Tier 2, Tier 3) and more.

Which Medical Coverage Level Is Best For Me?

Why It Matters

You want to get the right amount of coverage for your needs at the best price. Get help choosing the right level of coverage.

What to Do

If you need help deciding, there are tools to help you:

HSA Basics

An HSA—or Health Savings Account—is a special bank account that you can use when you enroll in a Bronze Plus or Silver coverage level. If you also have coverage under a second medical plan, it must also be a high-deductible option for you to use an HSA.

It's a great way to save for the future. Just set aside a few dollars from each paycheck now, and then you'll have funds to help cover health care expenses that come up. Plus, it's tax-free, so you're actually getting a better deal.

You can decide if you want to enroll in an HSA when you enroll for benefits. That's a great time to [decide how much to save](#).

You can change the amount you save at any time throughout the year.

Why Consider An HSA?

You'll be responsible for 100% of your medical and prescription drug expenses until you meet your deductible in the Bronze Plus or Silver coverage level. An HSA is a great way to pay less for those out-of-pocket expenses because you're using tax-free money.

Let's say you injure your knee. With a high deductible, you might worry about how you're going to afford the medical bills.

Now imagine if you had already set aside money for expenses like these. That's where an HSA comes in handy. You could already have saved the money you need.

An HSA allows you to set aside tax-free money to pay for qualified health care expenses. This includes your medical, dental, and vision copays, deductibles, and coinsurance.

It's Tax-Free—And Yours To Keep!

While no one likes taking money out of their paycheck, there are a number of advantages to setting aside a little money in an HSA.

It's tax-free when it goes in. You can put money into your HSA on a before-tax basis through convenient payroll contributions. You'll save money on qualified health care expenses and lower your taxable income.

It's tax-free as it grows. You earn tax-free interest on your money.

It's tax-free when you spend it. When you spend your HSA on qualified health care expenses, you don't pay any taxes. That means you're saving money on your qualified medical, dental, and vision expenses.

It's always your money. You can carry over your unused HSA balance from year to year. Just like a bank account, you own your HSA, so it's yours to keep and use even if you change medical options, leave the company, or retire.

Important! Make sure you use money in your HSA only for qualified health care expenses. Otherwise, you'll pay income taxes on that distribution. You'll also pay an additional 20% penalty tax if you're under age 65.

Which Account Should I Use

If you enroll in the Bronze Plus or Silver coverage level, you can use an HSA, a Health Care FSA, or both an HSA and Health Care FSA. If you contribute to an:

- HSA **or** Health Care FSA, you can use your account to pay for qualified medical, dental, and vision expenses.
- HSA **and** Health Care FSA, your Health Care FSA will be “limited purpose” and can only be used to pay for qualified dental and vision expenses. However, once you meet the medical plan deductible, then it can be used toward qualified medical expenses as well. Your HSA can be used for qualified medical, dental, and vision expenses.

If you enroll in the Bronze, Gold, or Platinum coverage level, you can use the Health Care FSA to pay for qualified medical, dental, and vision expenses.

How Much to Save?

You decide how much money you want to save in your HSA, and you can change it at any time. It's a smart idea to save enough to cover your annual deductible.

For 2026, you can save up to \$4,400 if you're covering just yourself, or \$8,750 if you're covering yourself and your family. If you're age 55 or older (or will turn age 55 during the plan year), you can also make additional "catch-up" contributions to your HSA up to \$1,000.

And if you don't need that much health care, your money stays in your account and earns tax-free interest. It's a great way to save for future expenses.

Prescription Drugs

Your prescription drug coverage will be provided through your insurance carrier's pharmacy benefit manager.

That means your prescription drug coverage depends on the medical coverage level you choose **and** your medical [insurance carrier](#).

Your Coverage Level Matters

You pay nothing for preventive drugs, as determined by your insurance carrier. You need a doctor's prescription, and you must use an in-network retail pharmacy or mail-order service.

Bronze Plus or Silver

You pay the full cost for prescription drugs until you reach the annual medical deductible. Then you pay coinsurance. Once you reach the out-of-pocket maximum, you pay nothing.

Bronze, Gold, or Platinum

You pay a copay for all prescription drugs. Once you reach the out-of-pocket maximum, you pay nothing.

Your specific prescription coverage is based on the medical coverage level you select. [Get the details](#).

Your Carrier Matters

Each pharmacy benefit manager has its own rules about how prescription drugs are covered. So you need to do your homework to find out how your medications will be covered—**before** choosing an insurance carrier.

Prescription Drug Questions

Your prescription drug coverage will be provided through your [insurance carrier's](#) pharmacy benefit manager. Each pharmacy benefit manager has its own rules about how prescription drugs are covered. So **you need to do your homework** to find out how your medications will be covered—**before** you choose an insurance carrier.

What To Ask

Here's a list of questions to ask each carrier you're considering.

Tip: You can also print out the [Prescription Drug Transition Worksheet](#) (PDF) and use it to take notes.

Is my drug on the formulary?

A formulary is a list of generic and brand name drugs that are approved by the Food and Drug Administration (FDA) and are covered under your prescription drug plan. If your drug isn't listed on the formulary, you'll pay more for it.

How much will my drug cost?

It depends on how your medication is classified—Tier 1, Tier 2, or Tier 3. Typically, the higher the tier, the more you'll pay.

While generics typically cost less than brand name drugs, higher-cost generics can be classified as Tier 2 or Tier 3 drugs. This means you'll pay the Tier 2 or Tier 3 price for certain generic drugs. You can find this information by using the prescription drug search tool when you enroll.

Will I have to pay a penalty if I choose a brand name drug?

Because many brand name drugs are so expensive, some medical insurance carriers will require you to pay the copay or coinsurance of a higher tier—**plus** the cost difference between brand and generic drugs—if you choose a brand when a generic is available.

Is my drug considered “preventive” (covered 100%)?

The Affordable Care Act requires that certain preventive care drugs are covered at 100% when you fill them in-network. You can view a list of drugs considered to be “preventive” when you enroll. If a drug isn't on the preventive drug list, you'll have to pay your portion of the cost.

Will my doctor have to provide more information before my prescription drug can be approved?

Many medications require approval before they are covered. This may apply for costly medications that have lower-cost alternatives or aren't considered medically necessary.

What is a step therapy program?

If this applies to one of your medications, you'll need to try using the most cost-effective version first—usually the generic. A more expensive version will be covered only if the first drug isn't effective in treating your condition.

Are there any quantity limits for my medication?

Certain drugs have quantity limits—for example, a 30-day supply—to reduce costs and encourage proper use.

How do I take advantage of mail-order service?

You'll likely need a new 90-day prescription from your doctor. Mail order can take a few weeks to establish. So it's a good idea to ask your doctor for a 30-day prescription to fill at a retail pharmacy.

Are weight loss drugs covered?

Medications prescribed for the sole purpose of weight loss are not covered. Note: When using digital.alight.com/rus/ prescription drug tool or looking at a carrier's formulary, you may still see the medications listed because they may be prescribed for other health conditions.

Medicare Basics

Medicare is a federal medical insurance program, which includes Original Medicare. Original Medicare is a low-cost government insurance program that guarantees access to health insurance for Americans age 65 and older and younger people with certain medical disabilities. It pays for many health care expenses, but not all.

How It Works

Medicare covers its share of an approved amount and you pay the rest through deductibles and coinsurance. Original Medicare is made up of two parts:

- **Part A is hospital insurance.** It covers inpatient hospital care, skilled nursing facilities, hospice, lab tests, surgery, and home health care.
- **Part B is medical insurance.** It covers things like clinical research, ambulance services, durable medical equipment, mental health services, limited outpatient prescription drugs, and more.

You are automatically eligible for Medicare Parts A and B when you become Medicare-eligible. If you are receiving Social Security benefits, you may be enrolled in Medicare automatically.

If you have to sign up to get coverage, you can enroll starting three months before the month you turn age 65. The deadline to enroll is three months after the month you turn age 65. (Note: You can wait to enroll in Part B; however, you may have to pay a late enrollment penalty. In general, you can wait to enroll in Medicare Part B without facing a late enrollment penalty until your active employment ends or the date your coverage under your employer's plan ends, whichever occurs first. Consult your Medicare advisor for more details.)

Part D is optional prescription drug coverage. You can enroll in Part D if you want coverage to help pay for your prescription drug costs.

How Medicare Works With Company Coverage

If you are actively employed, your company's health plan will be your primary medical coverage, and, if you choose to enroll in Medicare, Medicare will be your secondary coverage. Please note, once you are enrolled in any part of Medicare (Parts A or B), you can no longer make contributions to an HSA, even if you are also covered by an HSA-eligible medical plan.

If you are retired and have coverage through your previous employer, Medicare will be your primary medical coverage, and your company's health plan will be your secondary coverage.

As you prepare to transition to Medicare, you will want to understand if your dependents under age 65 will be eligible for coverage under your company's health plan.

How Medicare Works With COBRA

If you are eligible for Medicare Parts A and B but you choose to not enroll in Medicare Parts A and B, you may face potentially significant out-of-pocket expenses. COBRA coverage pays secondary to Medicare Parts A and B. Therefore, the plan will pay as if Medicare has already made a payment, even if the Medicare-eligible individual did not actually enroll in Medicare.

If your Medicare benefits (Parts A or B) become effective on or before the day you elect COBRA coverage, you can have COBRA and Medicare coverage. This is true even if your Part A benefits begin before you elect COBRA coverage but you don't sign up for Part B until later.

If you become entitled to Medicare after you've signed up for COBRA coverage, your COBRA coverage may be terminated by your plan as of the day you enroll in Medicare. (But if COBRA covers your spouse and/or dependent children, their coverage may continue.)

Accident Insurance

Accidents can slam your wallet too.

Even with medical coverage, your costs related to an accident can be hefty. Depending on the injury, you may be faced with copays, deductibles, hospital charges, transportation fees, and lodging expenses.

Accident insurance pays a benefit in the event you or a family member covered under this plan is in an accident. Accident insurance is not a replacement for medical coverage, but it can help pay deductibles and other gaps in coverage.

Things To Consider

When deciding whether to enroll in accident insurance, be sure to consider the following:

Cost per Paycheck

The cost of coverage is based on who you cover. You'll be able to see the cost per paycheck when you enroll through Your Benefits Resources at digital.alight.com/rus/.

Your and Your Family's Needs

Does your family lead an active lifestyle? Have you or an eligible family member suffered financial loss resulting from an accident? If you answered "yes" to either question, having accident insurance could give you peace of mind.

Other Coverage

Consider how accident insurance could fit in with other coverage for which you might enroll.

Critical Illness Insurance

When illness strikes, you can strike back. If you experience a serious health condition in the future, critical illness coverage can help lighten the load.

Even with medical insurance, a serious health condition could cost you. Critical illness insurance can provide you with extra cash when you need it most—if you or a family member covered under this plan is treated for a major medical event (such as a heart attack or stroke) or diagnosed with a critical illness (such as cancer or end-stage renal disease). Critical illness insurance is not a replacement for medical coverage, but it can help pay deductibles and other gaps in coverage.

Choose Your Coverage Level

If you decide you want critical illness coverage, you may choose \$10,000, \$20,000, \$30,000 or \$40,000 of coverage.

Cost per Paycheck

The cost of coverage is based on who you cover, age, tobacco status, and the level of coverage you elect. You'll be able to see the cost per paycheck for all your options when you enroll through Your Benefits Resources at digital.alight.com/rus/.

Your and Your Family's Needs

Does a serious health condition run in your family? Would you need financial help to offset the cost of a serious health situation? If you answered “yes” to either question, having critical illness insurance could give you peace of mind.

Hospital Indemnity Insurance

Even with medical insurance, hospital stays can be costly. You may have copays, deductibles, and other incidental hospital charges that add up. That's why you can buy extra insurance through hospital indemnity coverage.

Hospital indemnity insurance pays you a single lump-sum benefit in the event you or a family member covered under this plan is hospitalized. The benefit is based on the type of hospital stay. Hospital indemnity insurance is not a replacement for medical coverage, but it can help pay deductibles and other gaps in coverage.

A Word About Taxes

The IRS requires that you pay taxes on the value of certain benefits coverages extended to you by Ricoh. The value of these coverages is considered imputed income. This coverage includes vision benefits coverage for domestic partners and their eligible dependents.

Imputed income means that you pay federal income and Social Security taxes on the value of certain OnePlus benefits. Imputed income is paid so that the benefit is not considered taxable to you at the time you need it the most. Ricoh will report imputed income on your Form W-2 at year-end.

Vision Price

Find the right balance between what you pay out of your paycheck and what you pay when you get care.

Just like your medical coverage, your vision coverage costs will depend on a few factors:

The Coverage Level You Choose

The Bronze option will generally be less expensive per paycheck. That's because it covers only exams with some in-network discounts available. The Silver and Gold options will cost more per paycheck and provide coverage for exams as well as frames and lenses.

The Insurance Carrier You Choose

Certain insurance carriers may be able to provide a more competitive price per paycheck.

Your Dependents

You can enroll any combination of you, your eligible spouse/domestic partner, and your children in the option you choose.

Dental Coverage

Both PPO and DMO options are available. Make sure you understand the differences so that you can choose the type that's best for you and your family.

Cigna Dental PPO Options

Cigna will be the dental plan administrator for the dental PPO options. You'll pay the cost of dental coverage with before-tax dollars. In an effort to provide team members with both choice and flexibility, Ricoh will offer two dental PPO options—the Dental PPO Plus and the Dental PPO preventive option—both of which are administered by Cigna. By taking advantage of discounted rates through Cigna network dentists, the dental PPO allows Ricoh and team members to more effectively manage dental costs. Under these “active” PPO dental options, receiving care from a Cigna dentist results in lower out-of-pocket costs for you due to higher coinsurance percentages paid by the insurance carrier and in-network discounted rates. Although you may still choose to receive dental care from any dentist, if you receive care from an out-of-network dentist, you will pay higher out-of-pocket costs. Like your medical coverage, choosing dental coverage is a personal decision. As you make this decision, take a look at the highlights and the different deductibles and coinsurance amounts of the dental PPO options.

You are encouraged to submit a pre-treatment estimate if you expect to have dental work for which charges are anticipated to exceed \$250.

Both dental PPO options allow you to take advantage of network discounts and get more benefit for the annual maximum by using a Cigna network dentist. You are not required to use a Cigna network dentist; however, if you do not, you will pay more in out-of-pocket expenses under either of the dental PPO options.

The Cigna network of dentists is extensive and includes over 72,000 dentists across the country. Detailed access studies indicate that over 90% of Ricoh's team members live within 10 miles of at least two dentists in the Cigna network. To locate a Cigna dentist in your area, you can access the Cigna website at www.cigna.com. Click on "Find a Doctor" and be sure to search under "Dental: Total Cigna DPPO Network". You can also find providers using Provider Direct on the Your Benefits Resources website.

ID Cards will not be provided to members of the Cigna dental plans. When visiting your dentist, provide them with a Cigna dental claim form, which includes Ricoh's Cigna plan number. This Cigna claim form is available on RWorld and on <http://mycigna.com>.

Aetna Dental DMO Option

Aetna will be the carrier for the Dental DMO option. The Aetna Dental DMO option provides benefits for the same services that are covered under the Dental PPO options, but at a significantly lower out-of-pocket cost as long as you use a dentist that participates in the Aetna Dental DMO network.

The Aetna Dental DMO may be available to you depending on where you live. When you log in to Your Benefits Resources (YBR), you will see if the Aetna Dental DMO is available to you in your area. To locate an Aetna dentist in your area, you can access the Aetna website at <https://www.aetna.com/> or call them at **1.855.496.6289**.

Like a medical HMO option, if you elect coverage under the Aetna Dental DMO option you must seek dental care only from a dentist that participates in the Aetna Dental DMO network. In addition, you must elect a Primary Care Dentist (PCD) for each covered member of your family in order to access dental care. Failure to elect a PCD may result in claims being denied. Before you choose the Aetna Dental DMO option, you should check Aetna's online dental provider directory for a list of local participating dentists.

When you enroll in the Aetna Dental DMO, you must select a primary dentist. If you do not, you will not receive an ID card and claims may be denied.

If you select a dentist when you enroll, you will receive an ID card in the mail within the first few weeks of January.

No out-of-network benefits are paid through the Aetna Dental DMO.

The summary above describes only the Aetna Dental DMO option. A few other non-Aetna dental DMOs with slightly different plan designs are available in different locations across the U.S. For information on these other DMO options, please refer to the specific information listed on the Your Benefits Resources website.

A Word About Taxes

The IRS requires that you pay taxes on the value of certain benefits coverages extended to you by Ricoh. The value of these coverages is considered imputed income. This coverage includes dental benefits coverage for domestic partners and their eligible dependents.

Imputed income means that you pay federal income and Social Security taxes on the value of certain OnePlus benefits. Imputed income is paid so that the benefit is not considered taxable to you at the time you need it the most. Ricoh will report imputed income on your Form W-2 at year-end.

This overview serves as a summary on various Ricoh 2026 benefit plans. It is intended to provide an overview of information about some of the benefits you may be eligible for through Ricoh. If there is a discrepancy between the information displayed and the official plan documents, the official plan documents will govern.

Flexible Spending Accounts (FSAs)

By using the Flexible Spending Accounts (FSAs), you can save on health care or dependent day care expenses by setting aside pre-tax dollars. You can contribute from \$60 to \$3,300 to the Health Care FSA and from \$60 to \$7,500 to the Dependent Day Care FSA (\$3,750 if you are married and you and your spouse file separate income tax returns).

If you wish to contribute to a Health Care Flexible Spending Account and/or the Dependent Day Care Flexible Spending Account, you must make an active election every year. Elections **DO NOT** automatically roll over from year to year.

You can only use your FSA funds for eligible expenses incurred during the plan year. If you do not use all of the money in your FSAs for expenses that you incur before the end of the plan year, you lose it. Please be sure to anticipate your costs and FSA contributions carefully!

No Mid-Year Changes

If you elect to contribute to one or both of the FSAs, you will be allowed to stop contributing only if you experience a qualifying life event during the year. You'll have **31 days** from the date of your life event to stop contributions to your FSAs. Although you can't restart your contributions once you stop them, you can continue to receive reimbursements for eligible expenses incurred up to the point you stopped contributions.

Health Care FSA

The Health Care FSA allows you to reduce your taxable income and reimburse yourself for out-of-pocket medical, dental and vision costs for you and all your eligible dependents. You can elect to contribute from **\$60 to \$3,300** a year to the account.

NOTE: If you live in the U.S. mainland, enroll in the Bronze Plus or Silver medical option, and elect to contribute to a Health Savings Account (HSA), money contributed to the Health Care FSA cannot be used for medical expenses until you meet your combined medical and prescription drug deductible. FSA money may only be used for dental and vision expenses, and for unreimbursed medical and prescription expenses after your deductible is met. (If you live in Hawaii, this note does not apply to you.)

Call **1.800.953.2526** if you have questions regarding eligible Health Care FSA expenses. The Alight Smart-Choice Accounts section of the Your Benefits Resources website will provide you with additional information regarding FSAs.

Dependent Day Care FSA

The Dependent Day Care FSA reimburses you for certain dependent day care expenses, provided that you (and your spouse, if you're married) work full-time.

The Dependent Day Care FSA helps you pay for dependent day care expenses—for your child or a disabled spouse or parent—with tax-free dollars. You can elect to contribute from \$60 to \$7,500 to the Dependent Day Care FSA (\$3,750 if you are married and you and your spouse file separate income tax returns).

Eligible dependents for the Dependent Day Care FSA include:

- Children under age 13; or
- Dependents of any age that depend on you for more than half of their support and cannot care for themselves

Please note, if you are considered a highly compensated employee (HCE) in 2025, your Dependent Day Care FSA will be limited to \$3,300. For 2026, you are considered “highly compensated” if you had gross earnings of \$160,000 or more in 2025.

Using the Dependent Day Care FSA to fund expenses for the care of your family during the workday can also save you money in taxes, because your contribution dollars are deducted from your pay on a before-tax basis. Reimbursements for Dependent Day Care FSA expenses are made based on contributions made to date.

The types of expenses that can be reimbursed through the Dependent Day Care FSA include:

- Charges for dependent day care services at home or in a day care facility;
- Housekeeping expenses if a portion of these services is directly related to caring for the dependent; and
- Education expenses for children in nursery school.

About the Dependent Day Care Federal Tax Credit

The Dependent Day Care FSA is an alternative to the dependent day care federal tax credit on your federal income tax return. As a result, federal law precludes you from using the same expenses for both purposes. Instead, federal law requires that the money you set aside in your Dependent Day Care FSA lowers—dollar for dollar—the amount you can apply toward the dependent care tax credit. The Dependent Day Care FSA is usually more advantageous to you if your household income is more than \$24,000. Because every individual tax situation is different, you may want to consult a financial advisor to determine the best approach for you.

What You Can't Use a Dependent Day Care FSA for:

- Babysitting during non-working hours;
- Care by providers who don't supply a taxpayer identification number (Social Security number or employer identification number);
- Care by a family member who is under age 19 or someone you claim as a dependent on your tax return;
- Education costs for children in kindergarten or higher convalescent nursing home expenses; and
- Dependent health care expenses.

FSA Administrator

Benefits Express, through its **Alight Smart-Choice Accounts** website, is Ricoh's FSA administrator.

The Alight Smart-Choice Accounts Website

You'll find useful information and tools to help you manage your FSA account(s) through the Alight Smart-Choice Accounts website. Among the features of this website, you'll be able to:

- Submit your FSA claims and review FSA claim status;
- Learn about eligible FSA expenses;
- Check your current FSA balance(s); and
- Get information about the new Health Care FSA debit card program.

The Alight Smart-Choice Accounts website is available 24 hours a day, seven days a week from any computer with Internet access. You can access the site via a link from the Your Benefits Resources website.

The Health Care FSA Debit Card Program

If you enroll in the Health Care FSA for the first time for at least \$100, you will receive an Alight Smart-Choice Accounts debit card, which is a special Mastercard debit card that you can use to pay for eligible health care expenses. Using the debit card is easy and more convenient than submitting claim forms because your eligible health care expenses will be deducted automatically from your Health Care FSA. Be sure to retain all receipts for your health care spending account purchases as supporting documentation may be required.

More Information

After you complete your OnePlus enrollment elections and elect to contribute to a Health Care FSA for the first time, detailed information regarding the Health Care FSA debit card program will be mailed to your home address. Please note that the debit card program is only available for the Health Care FSA; it is not available for use with the Dependent Day Care FSA. You must elect at least \$100 into your Health Care FSA to be issued a debit card.

Keep in mind that you are not permitted to transfer dollars between flexible spending accounts. Once designated for the Health Care FSA or Dependent Day Care FSA it must remain in that account.

Life Insurance

Life insurance is available for yourself, your spouse, and your children.

Employee Life And Supplemental AD&D Coverage

OnePlus offers basic life and basic Accidental Death and Dismemberment (AD&D) insurance and supplemental life and AD&D coverage designed to provide you with different levels of financial protection and security. It’s up to you to choose the level of life insurance/AD&D coverage that suits your specific needs. As you make your choice, you should consider any life insurance/AD&D coverage you have outside of Ricoh.

Ricoh pays for your basic employee life and AD&D insurance coverage in an amount equal to one times your Annualized Benefits Salary (ABS) to a maximum of \$100,000. If you desire a higher level of life insurance/AD&D coverage, you can elect supplemental coverage of up to seven times your Annualized Benefits Salary, to a maximum of \$1 million of coverage. Please note that for voluntary coverage amounts of \$600,000 or more, you’ll need to provide proof of good health by completing an Evidence of Insurability form.

MetLife will be Ricoh’s employee life and AD&D carrier.

Annualized Benefits Salary

Annualized Benefits Salary (ABS) is the pay that is used to determine your employee life and AD&D insurance coverage, disability coverage, and medical subsidy credit each year. For 2026, the ABS is calculated by adding your base salary and commissions from October 1, 2024 through September 30, 2025. For new hires, Annualized Benefits Salary is based on the base salary plus commissions at hire date, rounded to the next \$1,000.

Bonuses are not included in the calculation of ABS.

Once your ABS and the salary band is determined in September, it becomes effective as of January 1 and remains in effect throughout the year.

Reductions To Employee Life Coverage

Each year, reductions are based on your Annualized Benefits Salary and your elected coverage level and rounded to the next \$1,000. For example, if you reach age 65 in 2026, your 2026 elected coverage amount will be reduced by 25%. The premium you pay for any supplemental employee life and AD&D coverage will be based on the coverage amount after the applicable age reduction.

Evidence Of Insurability

If your supplemental employee life/AD&D coverage election equals \$600,000 or more, you will need to complete an Evidence of Insurability form. This form will be sent to you by MetLife shortly after you enroll. If your Evidence of Insurability form is approved by MetLife, the coverage you've elected will take effect on the first of the month following the date of approval. Until then, you will receive the next multiple level you elected under \$600,000. You must be actively employed as of January 1 to receive employee life and AD&D insurance coverage in 2026. If you enroll, but are not actively employed as of January 1, 2026—you are on a leave of absence, for example—any benefits payable to you or your beneficiary will be based on the coverage amount in effect in 2025. Once you return to active employment in 2026, your 2026 coverage amounts will take effect provided you made all required premium payments during your leave.

Spouse And Dependent Life Options

The spouse and dependent life insurance options are designed to help you meet the expenses associated with a family member's death. If you elect either of these insurance coverages, you are automatically the beneficiary.

Spouse Life Options

- No Coverage
- \$25,000 option
- \$50,000 option
- \$75,000 option*
- \$100,000 option*

Dependent Life Options

- No Coverage
- \$10,000 per child

If your spouse and/or dependent is employed by Ricoh, they are not eligible to be covered under spouse and dependent life insurance options.

* Spouse life insurance over \$50,000 will be subject to approval with an Evidence of Insurability (EOI) form. In such a case, spouse life insurance will take effect as of the first of the month after the EOI form is received and approved. Until the coverage is approved, you will receive the highest coverage available or \$50,000.

A Word About Taxes

The IRS requires that you pay taxes on the value of certain benefits coverages extended to you by Ricoh. The value of these coverages is considered imputed income. This coverage includes:

- Employee life insurance coverage that exceeds \$50,000 in value (based on age-related rates set by the IRS)
- Spouse life and dependent life insurance

Imputed income means that you pay federal income and Social Security taxes on the value of certain OnePlus benefits. Imputed income is paid so that the benefit is not considered taxable to you at the time you need it the most. Ricoh will report imputed income on your Form W-2 at year-end.

This overview serves as a summary on various Ricoh 2026 benefit plans. It is intended to provide an overview of information about some of the benefits you may be eligible for through Ricoh. If there is a discrepancy between the information displayed and the official plan documents, the official plan documents will govern.

Disability

Recuperating from surgery? Having a baby? From short-term absences to serious illnesses or injuries that prevent you from working for years, coverage is available.

Short-Term Disability (STD)

If you are going to be absent from work for more than seven days because of maternity or a non-occupational injury or sickness, you may be entitled to STD benefits. However, your disability must be certified by a qualified physician and approved by Ricoh's disability insurance carrier before STD benefits are paid.

MetLife will be Ricoh's short-term disability carrier. Ricoh pays the full cost of basic STD benefit coverage. Basic STD coverage is equal to **50%** of your Annualized Benefits Salary (ABS) and payable for 26 weeks while you are disabled. You may also choose to increase your income protection and elect to purchase, at your cost, supplemental STD coverage (Buy-Up coverage) for the higher monthly maximums, as summarized below:

STD Options

STD Basic Benefit Option (50% ABS): Maximum weekly benefit of \$1,500 for up to 26 weeks

STD "Buy-Up" Option (66.67% ABS): Maximum weekly benefit of \$4,000 for up to 26 weeks

Any STD benefits you receive under OnePlus will be reduced by Social Security disability benefits and other similar benefits, such as worker's compensation, that you may be eligible to receive while you are disabled.

The STD Plan contains a pre-existing condition exclusion that limits the eligibility of certain team members to receive STD benefits.

For newly hired team members, this pre-existing exclusion period includes the 30 days prior to employment by Ricoh. If a team member suffers a disability during the first 12 months after STD coverage becomes effective that is determined to be a pre-existing condition, this disability will not be covered under the STD Plan. For current team members, the pre-existing condition exclusion applies to any team member who elects STD Buy-Up coverage, **but it applies only to the additional STD Buy-Up coverage**. For example, a team member with a pre-existing condition based on treatment received anytime during the three months just prior to January 1 will not be eligible for any STD Buy-Up coverage for that disability related to the pre-existing condition, but rather will receive STD benefits at the basic coverage level for that disability.

Long-Term Disability (LTD)

If you become disabled, you may be eligible to receive LTD benefits after the first 180 days of the disabling condition. Your disability will need a qualified physician's certification and approval by Ricoh's disability insurance carrier, before LTD benefits are paid. Ricoh pays the full cost of basic LTD benefit coverage. Basic LTD coverage is equal to 50% of your Annualized Benefits Salary to certain maximum monthly benefits, depending on your length of service with Ricoh. You may elect to purchase, at your cost, supplemental LTD coverage (Buy-Up coverage) equal to 66.67% of Annualized Benefits Salary to a higher maximum monthly benefit. Any LTD benefits you receive

under OnePlus will be reduced by Social Security disability benefits and other similar benefits, such as worker's compensation, that you may be eligible to receive while disabled. MetLife will be Ricoh's long-term disability carrier.

A Summary Of LTD Benefits

The LTD plan also contains a pre-existing condition exclusion that limits the eligibility of certain team members to receive LTD benefits.

For newly hired team members who become eligible for LTD benefits, pre-existing condition exclusion is also in place under the LTD plan. For current team members, the pre-existing condition exclusion applies to any team member who elects LTD Buy-Up coverage, but it applies only to the additional LTD Buy-Up coverage. Team members who receive any treatment just prior to January 1 will not be covered for any LTD Buy-Up coverage for that disability related to the pre-existing condition, but rather will receive LTD benefits at the basic coverage level for that disability.

You must be actively employed as of January 1, 2026 to receive STD and LTD coverage in 2026. If you enroll for 2026, but are not actively employed as of January 1, 2026—you are on a leave of absence, for example—any benefits payable to you or your beneficiary will be based on the coverage amount in effect in 2025. Once you return to active employment in 2026, your 2026 coverage amounts will take effect provided you made all required premium payments during your leave.

LTD Options

LTD Basic Benefit Option: 50% of ABS with a maximum monthly benefit of \$10,000

LTD "Buy-Up" Option: 66.67% of ABS with a maximum monthly benefit of \$16,499

A Word About Taxes

The IRS requires that you pay taxes on the value of certain benefits coverages extended to you by Ricoh. The value of these coverages is considered imputed income. This coverage includes short-term disability and long-term disability benefits coverage.

Imputed income means that you pay federal income and Social Security taxes on the value of certain OnePlus benefits. Imputed income is paid so that the benefit is not considered taxable to you at the time you need it the most. Ricoh will report imputed income on your Form W-2 at year-end.

Pre-Existing Conditions and Disability

For the STD and LTD plans, a pre-existing condition is any medical condition for which you have received medical treatment, medical advice, care or services, including diagnostic measures, or for which you took prescribed drugs or medicines in the three months immediately prior to the effective date of coverage.

This overview serves as a summary on various Ricoh 2026 benefit plans. It is intended to provide an overview of information about some of the benefits you may be eligible for through Ricoh. If there is a discrepancy between the information displayed and the official plan documents, the official plan documents will govern.

Legal Services

Group legal coverage does not roll over from year to year. If you want coverage under LegalEASE, you will need to elect coverage during enrollment. If you elect to join LegalEASE, coverage will begin January 1 and remain in effect through December 31, and you must participate for the full year.

Group Legal Plan

The LegalEASE group legal plan is available to all OnePlus eligible team members during annual enrollment this year.

Most people don't have an attorney, fear the high cost of legal fees and don't know how to find an attorney if they have a legal issue. LegalEASE provides you with easy access to pre-qualified attorneys and covers most personal legal matters. They also provide legal assistance in connection with:

- Preparation of estate planning documents, including simple and complex wills, trusts, living wills and powers of attorney;
- Real estate matters, including the purchase or sale of a home, refinancing a home, tenant negotiations and property tax assessments;
- Financial matters, including personal bankruptcy, debt collection and identity theft;
- Traffic violations, excluding DUI;
- Family law matters, including adoption assistance and premarital agreements; and
- Consumer protection matters, including small claims assistance.

Note: Please be advised that no employment-related matters are covered by LegalEASE.

Under LegalEASE, participating team members and their eligible OnePlus dependents are provided with telephone and office consultations for an unlimited number of covered legal matters, and all covered matters are 100% paid for by the plan. LegalEASE has an extensive network of pre-qualified attorneys, allowing participants to choose from attorneys across the country.

The cost of coverage is fully paid for by you, if you elect to participate. The cost is \$7.19 per bi-weekly pay period (\$15.58 per month) and is automatically deducted from your paycheck on an after-tax basis.

Even if you don't anticipate needing legal assistance, you should still consider whether LegalEASE is right for you in the event of an unexpected situation.

Identity Theft Protection

Victims of identity theft spend countless hours trying to sort out the damage.

Identity theft protection could help you catch fraud in its early stages through 24/7 monitoring of your personal and financial information. It can also help you act quickly to limit damage if your personal or financial information is stolen.

Identity theft protection is a voluntary benefit administered by NortonLifeLock. The plan covers all eligible family members. And you can drop coverage at any time during the year.

Things To Consider

When deciding whether to enroll in identity theft protection, be sure to consider the following:

Cost per Paycheck

You'll be able to see the cost per paycheck when you enroll.

Your Risk Factors

While everyone has risk, some people are at greater risk than others. Have you used credit cards on unsecure websites? Do you make online purchases regularly? If you answered "yes" to either question, having identity theft protection could give you peace of mind.

Vacation Purchase Program

Ricoh will continue to offer a Vacation Purchase Program (VPP) during benefits open enrollment to all team members except those residing in the state of California. The VPP will allow team members to purchase from one to five additional vacation days on a before-tax basis during annual enrollment. Purchased days will be available for use on January 1, 2026 and must be used by December 31, 2026 or will be forfeited.

The cost for purchased days will be determined by dividing your annual base pay as of September 30, 2025 by 260 working days, with the cost to you being deducted from your pay over the course of 2026. Additional vacation days purchased through the VPP will be tracked as Vacation Purchase Program days through the applicable payroll recordkeeping system. Managers of team members who elect to purchase additional vacation days will be informed of the number of days purchased for each direct report and will be expected to track these days appropriately.

If the team member under the Sample Calculation below elected to purchase an additional five vacation days through the VPP, \$28.85 would be deducted on a before-tax basis from each bi-weekly paycheck in 2026.

If you are a part-time team member, your calculation will be based on the number of hours you are scheduled to work in a year.

The VPP is a completely voluntary benefit that can be used at your discretion and is a “use it or lose it” program. **Any days not used at the end of the year or upon termination will not be paid out and will be forfeited.** As always, team members who elect additional vacation days are required to work with their Manager in scheduling when any additional vacation days are to be used before December 31, 2026.

Sample Calculation

Below is a sample calculation of the cost of purchasing additional vacation days based on an annual base pay as of September 30, 2025 of \$39,000:

= Annual base pay ÷ 260

= \$39,000 ÷ 260

= \$150 for 1 day of vacation

Total cost for five additional vacation days through the VPP:

= \$150 x 5 days

= \$750 Total

Important Considerations

- If you wish to purchase VPP days, you must make an active election to do so. Elections you made for the current year will NOT be automatically rolled over.
- Team members with a vacation excess bank of eight hours or more are NOT eligible to participate in the Vacation Purchase Program.

Bill Negotiation Services

You don't have to be a health care expert when you have one in your corner.

Bill negotiation services puts years of health care and billing expertise to work for you. When you're facing a large bill from an **out-of-network** provider, negotiators are available to partner with you and your providers to make sure the amount billed to you is appropriate (which could reduce the amount you owe). In many cases, negotiators can help save you 20% or more.

Bill negotiation services is administered by MCA. You do **not** need to enroll for coverage. When you have a bill of at least \$300, you can sign up and get started at www.medicalcostadvocate.com/aon or call **1.844.891.8981** for more information.

Paying For Coverage

If you don't save any money through bill negotiation services, it's totally free. If you **do** save money through bill negotiation services, you'll pay 35% of your savings.

Things To Consider

When deciding whether to use bill negotiation services, be sure to consider the following:

It's Risk-Free

Because you only pay if negotiators save you money, you have nothing to lose—and a smaller provider bill to gain.

Peace of Mind

Provider Network

Bill negotiation services can save you money on large, out-of-network provider bills. Just remember, you will receive the highest benefit by using in-network providers. You also have **Health Pros** that are available to help with benefits or billing issues.

Logging on for the first time? From Your Benefits Resources, register as a new user and follow the prompts to provide requested information and set up your username and password.

Following your enrollment, you may still need to take action. If you do, the required follow-ups will appear on a confirmation page.

Actions After You Enroll

Now that you've enrolled, it's time to focus on the road ahead. And there are things you need to do **now** to use your benefits successfully when they take effect.

Here's your to-do list:

Know How Your Prescription Drug Plan Works

Your prescription drug coverage is provided through your insurance carrier, who sets the rules for how medications are covered. Visit your carrier's website for information about your medications. You can also check out the [Prescription Drug Transition Worksheet](#) (PDF) for tips and questions you may need to ask your carrier.

Check the Formulary

A **formulary** is a list of generic and brand name drugs that are approved by the Food and Drug Administration (FDA) and are covered under your prescription drug plan. [Check with your carrier](#) to make sure your drug is listed on the formulary **before** you fill it. If it isn't, you'll pay more.

Go Generic

Generic drugs meet the same standards as brand name drugs, but they **typically** cost less. And, because brand name drugs can be expensive, some carriers don't cover them **at all** if a generic is available. Ask your doctor if a generic drug is available for you.

Mail-Order Setup

Mail-order service can save you a trip to the pharmacy and may reduce your costs. To set up mail order with a new medical insurance carrier, you'll likely need a new 90-day prescription from your doctor. Because mail-order can take a few weeks to establish, it's a good idea to ask your doctor for a 30-day prescription to fill at a retail pharmacy in the meantime.

“Transition Of Care” Setup

Are you or a covered family member pregnant? Will you or your covered family member continue needing treatment for an ongoing medical condition?

If you will have a new medical insurance carrier and you answered “yes” to either question, you may be able to temporarily continue that care with your current provider once your **new** medical coverage begins. This is true even if your provider isn't in the new insurance carrier's network.

If you think this applies to you, [call customer service](#) at your **new** medical insurance carrier as soon as possible to ask for help with “transition of care.”

Give your new insurance carrier information about your treatment and the providers you use today.

Avoid Unexpected Out-Of-Network Costs

It's very important to know whether your doctor participates in your medical insurance carrier's network.

You Could Pay a Lot More for Out-of-Network Care

Insurance carrier member sites and apps have resources that can help you look up the cost of care. But your medical insurance carrier could pay a much lower benefit if you see an out-of-network doctor—leaving you to pay the rest.

For instance, you will pay more through a higher out-of-network deductible and higher coinsurance. You'll also have to pay the entire amount of the out-of-network provider's charge that exceeds the maximum allowed amount, even after you've reached your annual out-of-network out-of-pocket maximum.

Each medical insurance carrier can determine its maximum allowed amounts for out-of-network providers. For example, among other ways, carriers may use what's considered "reasonable and customary" and/or a Medicare-based calculation to determine the maximum allowed amount.

Example

For example, let's say you will have an out-of-network surgery that costs \$5,000 and you will pay 45% coinsurance. The maximum allowed amounts could be different across carriers:

- If one carrier has a maximum allowed amount of \$2,000, you would owe 45% of \$2,000 and 100% of the remaining \$3,000, for a total of \$3,900.
- If a second carrier has a maximum allowed amount of \$3,000, you would owe 45% of \$3,000 and 100% of the remaining \$2,000, for a total of \$3,350.

Take These Steps to Protect Yourself

If you *didn't* check your doctor's status before you enrolled or you want to look up a different doctor, do it *now*—before making an appointment with that doctor.

You can check the provider directory through Your Benefits Resources at digital.alight.com/rus/ or your [insurance carrier's website](#).

Important! Do not rely on your provider's office to know the carriers' network(s). If you have any uncertainty (for instance, covering out-of-area dependents) or you need the network name, call the insurance carrier.

Even if you're keeping the same insurance carrier, the provider network could be different. **Always** check the provider directories on the carrier preview sites before making a decision.

If your doctor is out-of-network and you still want to see them, check the cost with your doctor *before* you get care. Then ask your doctor to confirm the portion that will be covered by your medical insurance carrier and the portion for which you'll be responsible. That way you'll be prepared for any potentially significant costs.

When To Expect New Cards

You'll get a printed or digital ID card when you enroll for the first time or change insurance carriers or coverage levels. You'll use your ID card for medical and prescription drug needs. (**Note:** You can access digital ID cards via the carrier's member website or app.)

For questions about ID cards, [contact the insurance carrier](#). If you need an ID card immediately, go to your insurance carrier's website, register online, and print a temporary ID card.

Contributing To An HSA?

If you enrolled in the Bronze Plus or Silver coverage levels, you had the option to elect to contribute to an HSA.

If you decided to put money in an HSA for the first time, you'll receive a welcome letter and HSA debit card in the mail. If you decided to put money in your HSA and you've previously contributed to the HSA, you'll continue to use your existing debit card. New money added to your account will be accessible through your current debit card.

HSA vs. FSA: Which One Should You Use?

If you enrolled in an HSA **and** a Health Care Flexible Spending Account (FSA), you will use the same debit card for **both** accounts. And Alight Smart-Choice Accounts will automatically follow IRS guidelines on how to use each account. So when you use the debit card to pay for medical, dental, or vision expenses, the expense will automatically be deducted from the correct account.

How to Get Care

When you get care, it helps to know what you can expect. Remember, insurance carrier member sites and apps have resources that can help you look up the cost of care before you go.

Getting Care At The Doctor's Office

Present your medical ID card at your doctor's office. If you're enrolled in the Bronze Plus or Silver coverage levels, you can wait to pay until your insurance carrier processes the claim and you get your doctor's bill.

When it's time to pay, you can [pay with your HSA](#), FSA, or pay another way—it's your choice!

Filling Prescription Drugs At A Retail Pharmacy

Present your medical ID card each time you drop off a prescription. If payment is due, you pay out of pocket (or you can [pay with your HSA](#) or FSA if you have one).

Know When You'll Owe

If your doctor bills services as preventive care or your medication is listed as preventive on the formulary, you'll owe nothing. For other types of covered services or non-preventive prescription drugs, you could owe a deductible, copay, and/or coinsurance.

Remember: You'll Pay Less With In-Network Providers

You can check the provider directory on Your Benefits Resources at digital.alight.com/rus/ or refer to your [insurance carrier's website](#).

If a doctor is out-of-network and you still want to see them, check the cost with the doctor before you get care.

Then, ask the doctor to confirm the portion that will be covered by your medical insurance carrier and the portion for which you will be responsible.

That way, you'll be prepared for potentially significant costs.

Remember: Not all options cover out-of-network care.

Paying for Care

When you receive medical care, you choose how to pay your share of the cost. Follow these easy steps when it's time to get care:

Step 1: Meet With Your Provider

Don't forget, you'll probably pay **a lot** less when you see in-network providers. You can check the provider directory on Your Benefits Resources at digital.alight.com/rus/ or refer to your [insurance carrier's website](#).

Remember: Not all options cover out-of-network care.

Step 2: Present Your Medical ID Card

When you visit your doctor, hospital, or other health care provider, remember to show them your ID card so they know how to bill for the services they are providing you.

Step 3: Review The Explanation Of Benefits (EOB)

An EOB is **not** a bill. It's simply a statement from your insurance carrier that shows when you got care and how much it cost.

It will show your provider's charges, the negotiated amount your insurance carrier agreed to pay, how much is covered (if any), and your payment responsibility.

Remember, if you haven't met your deductible, you could owe the entire negotiated amount. Keep the EOB for your records because you'll need it for the next step.

Step 4: Review Your Provider's Bill

A provider's bill typically arrives in your mailbox after the EOB arrives. The amount you owe on your provider's bill should match what's on the EOB.

Step 5: Pay Your Provider

You can pay your provider out of pocket or you can [pay with your HSA](#) or FSA for eligible health care expenses.

Paying With Your HSA

You can open an HSA if you enrolled in a Bronze Plus or Silver coverage level. When it's time for you to pay for care or prescription drugs, your HSA gives you options:

Use Your HSA Debit Card

Just use it when you're ready to pay for qualified medical expenses. The funds will be taken directly from your account.

Make sure you only use the card for eligible expenses, and that you have enough money in your HSA to cover it.

Log on to Your Benefits Resources at digital.alight.com/rus/ to check your balance beforehand.

Pay Out Of Pocket

If you prefer, you can pay for your expenses up front and pay yourself back through your HSA later. You'll log on to Your Benefits Resources at digital.alight.com/rus/ to transfer money from your HSA to your regular bank account.

Set Up Direct Payments

Another option is to have Alight Smart-Choice Accounts make direct payments to your provider from your HSA.

Log on to Your Benefits Resources at digital.alight.com/rus/ to set up direct payments.

Eligible Expenses

You can find a complete list of eligible expenses at <https://www.irs.gov/publications/p502>.

Don't forget! If you use money from your HSA to pay for nonqualified expenses, you'll pay taxes on that money. You'll also pay an additional 20% penalty tax if you're under age 65. This applies to expenses such as child care, cosmetic surgery, health club fees, teeth whitening products, and vitamins.

Keep Your Receipts!

Always remember to save your receipts when you make payments from your HSA, in case you need to provide proof of your eligible expenses to the IRS.

Bill negotiation services may be able to save you 20% or more.

If you aren't satisfied with the resolution, you can file an appeal through your **insurance carrier**, who will be able to direct you through that process. Ricoh doesn't have any influence on the outcome. The insurance carrier—not Ricoh—is responsible for the cost of claims.

Not sure where to start? Once your coverage has begun, contact your **insurance carrier**. Your insurance carrier is most knowledgeable about coverage rules and has the final decision on all claims and billing questions.

Need Help? Your Health Pro Is Waiting.

Reach out to your Health Pro and they will guide you through the required steps and important deadlines. Your Health Pro can also manage the back-and-forth between your health insurance and doctor, as needed.

Brand Name

A more expensive prescription drug for which there is an active patent. (A patent is a time-sensitive right to market a drug under a certain name.)

Coinsurance

The percentage of costs you pay for eligible expenses after you meet the deductible.

Copay

A flat-dollar amount you pay for certain covered services.

Coverage Level

A benefit level that determines how services are covered.

Deductible

What you pay out of your own pocket before your insurance begins to pay a share of your costs.

[How the deductible works](#) depends on your coverage level. Out-of-network charges do **not** count toward your in-network annual deductible. They only count toward your out-of-network deductible.

Explanation of Benefits (EOB)

An EOB shows the claim filed by your health care professional, what was paid, and what your portion of the payment was or will be. Your insurance carrier provides the EOB. It's not a bill.

Formulary

A list of generic and brand name drugs that are approved by the Food and Drug Administration (FDA) and are covered under your prescription drug plan. You should make sure your medication is on the formulary of the medical insurance carrier you choose.

Generic

Medications that have been approved by the FDA as safe and effective. These medications contain the same active ingredients in the same amounts as brand name products. Generics may be different in color, shape, or size from their brand name counterparts. Your physician may substitute a generic for a brand name drug to save you money.

Health Savings Account (HSA)

A special bank account that allows you to set aside tax-free money to pay for qualified health care expenses. These include your medical, dental, and vision copays, deductibles, and coinsurance.

HMO

Health Maintenance Organization (HMO) options offer care through a network of doctors and hospitals. All of your care generally must be provided through the HMO network and coordinated through the HMO primary care physician (PCP) you select when you enroll. Except in emergencies, your care is usually covered only if it's coordinated by your PCP. There's no coverage for out-of-network care.

Network

A group of health care providers that offer services to participants in a health plan at a negotiated, discounted cost. You'll save money if you use doctors inside your carrier's network.

Out-of-Pocket Maximum

The most you have to pay for covered medical services in a year. Generally, it includes any applicable deductible, copayments, and/or coinsurance. [How the out-of-pocket maximum works](#)

depends on your coverage level. Out-of-network charges do **not** count toward your in-network annual out-of-pocket maximum. They only count toward your out-of-network out-of-pocket maximum.

Payroll Contribution

The amount deducted from your paycheck on a pre-tax basis to cover your share of health care benefit costs.

Pharmacy Benefit Manager

The insurance carrier or third-party administrator who manages your retail and mail-order prescription drug benefit.

PPO

A Preferred Provider Organization, or PPO, is a type of medical plan that uses a network of physicians, hospitals, and other health care providers that have agreed to provide care at negotiated prices. You can also go to out-of-network providers, but you'll pay more.

Preventive Care

Annual physicals, wellness screenings, immunizations, well-woman exams, well-baby exams, and more. In-network preventive care is 100% covered without having to pay your deductible.

Reasonable and Customary

The normal charge made by a licensed practitioner in a specific area for a specific service. It doesn't exceed the normal charge made by most providers in the area where the service is provided.

Traditional Deductible

Once a covered family member meets the individual deductible, your insurance will begin paying benefits for that family member. Expenses for all other family members will continue to count toward their individual deductible *and* the family deductible. Once any individual family member or combination of family members meet the family deductible, the plan will begin paying coinsurance for all covered members.

Traditional Out-of-Pocket Maximum

Once a covered family member meets the individual out-of-pocket maximum, your insurance will pay the full cost of covered charges for that family member. Expenses for all other family members will continue to count toward their individual out-of-pocket maximum *and* the family out-of-pocket maximum. Once any individual family member or combination of family members meet the family out-of-pocket maximum, the plan will begin paying the full cost of covered charges.

True Family Deductible

The entire family deductible must be met before your insurance will pay benefits for any covered family member.

True Family Out-of-Pocket Maximum

The entire family out-of-pocket maximum must be met before your insurance will pay the full cost of covered charges for any covered family member.

Need To Enroll For 2025 *And* 2026 Benefits?

If you’re enrolling in benefits for the rest of 2025 and all of 2026, you should know what to expect for both years. While most things don’t change from year to year, some things could be different.
